

# 2011 CAMPER/VEHICLE PARKING RULES

## SEASON PASSES MUST BE PURCHASED IN ORDER TO CAMP

Each camper will be given one parking pass. Pass needs to be hung from the rear view mirror. There is to be only **one car at each camper**. If you do not need your car during the fair, please park it in one of the designated parking areas. **There will be no 2<sup>nd</sup> car passes given.**

Some areas will not be able to park a vehicle at their campers.

Anyone that violates the parking rules will be given a warning. If a 2<sup>nd</sup> vehicle is parked at your camper, **it will be towed at the owner's expense**. If violations continue, your camping privileges will be terminated for the remainder of the fair. If you lose your camping privileges, your application for future camping will have to be approved by the camping committee.

**Any 4 wheeler, golf cart, etc. must be approved each year by the fair board.** This privilege is reserved for fair personnel and those individuals who require special consideration for medical or other reasons. Again, use of these vehicles must be approved by the fair board.

## **2011 Jackson County Junior Fair Camping Rules**

Camping is for livestock exhibitors, board of directors, fair personnel, and teachers. Other camping requests will be considered should sites become available.

Please understand we will do our best to accommodate all requests.

Due to the increasing number of camping exhibitors and a limited number of sites, space will be limited to 50% of the distance between hook-ups. Campers with slide outs will get the same amount of space.

Water, sewer and electricity are limited. Please understand that all hookups have to be shared. Please plan accordingly. **Due to electrical problems outside lights and appliances will be prohibited. Only factory installed air conditioners will be allowed.**

The Jackson County Junior Fair will not be held responsible for any electrical repairs or damages to campers while on the campground.

**Everyone must have season passes or they must purchase season passes when they park their campers.**

Only one car at each campsite where permitted.

No exhibitors are permitted to stay in a camper overnight without parental supervision.

Curfew is 12:00 midnight or 45 minutes after the end of the last event.

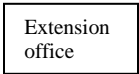
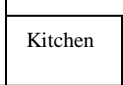
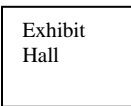
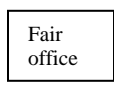
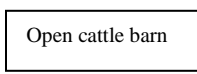
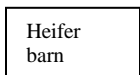
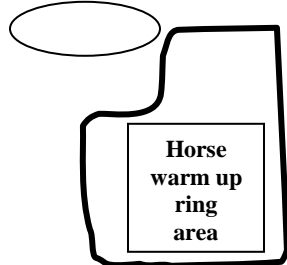
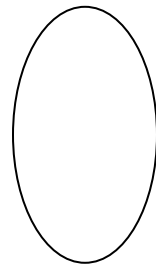
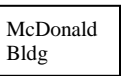
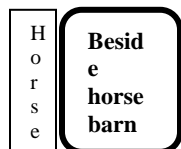
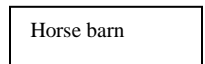
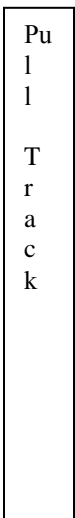
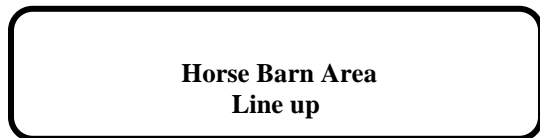
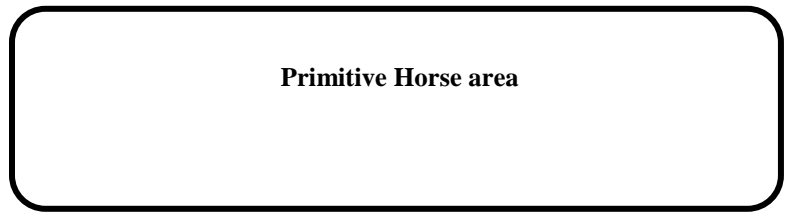
- Be considerate to your neighbors

All porta-pots are expected to be emptied at the dumping station located below the steer barn. Please do not dump port-a-pots in restrooms or on the ground. The sanitation personnel are available to pump out your holding tank during the week for \$15. Contact the fair office at 304-372-5066 to schedule a time for service.

Please help keep the campgrounds clean. There will be trash cans on the grounds.

Please understand no campers will be allowed to leave the campgrounds until 6:00 am, Sunday, July 31<sup>st</sup>.
